## National Federation of Nonpublic School State Accrediting Associations (NFNSSAA)

The annual meeting for NFNSSAA was held on June 7-8, 2022, in Chicago, IL. The meeting focused on state membership reports, NFNSSAA mission & vision, Federation strategies, and the topics for future conference calls. ## **Council for Private Education (CAPE)**

The annual State CAPE Network (SCN) meeting was held on July 10-12, 2022, in Colorado Springs, CO. The meeting focused on School Choice, private school trends, public policy advocacy, and decisions from the U.S. Supreme Court affecting private school education. Arkansas nonpublic schools were represented in the meeting by Kristine Grelle, AR SCN representative, and Dr. Gary Arnold, CAPE Board member.

### ANSAA 2022-2023 Policy Manual

The ANSAA Board of Directors made one change to the policy manual for the 2022-2023 school year. Schools will no longer need to be established for one full year before becoming eligible to join as a Non-Accredited Associate Member. All mandatory standards are in effect for this school year. All waivers have been lifted and requirements for Alternative Methods of Instruction are reinstated.

"Schools may develop a plan for alternative methods of instruction (formerly referred to as Inclement Weather Make-Up Days) to be used on days when administration closes school due to exceptional or emergency circumstances. Schools may designate up to an equivalent of ten (10) student attendance days for the use of alternative methods of instruction, including virtual learning, on days when the school is closed due to exceptional or emergency circumstances such as: a contagious disease outbreak, inclement weather, physical disasters, or a utility outage. The instruction plan shall demonstrate how teaching and learning will not be negatively impacted by the use of alternative methods of instruction (i.e., lessons must be current, tied to grade level curriculum standards, and approved by the Head of School)." #### Trauma Resource Initiative for Schools

The Trauma Resource Initiative for Schools (TRIS), funded by the Blue & You Foundation, provides training, resources, and other support to help better recognize and respond to the impact of trauma on students. Support is provided to all schools and families through these main avenues:

- 1. Professional Development Trainings (Trainings require 10 or more people and can be presented in-person or virtually)
  - "Supporting Students During Difficult Times" (2 hours)
  - "Supporting Students During Difficult Times" (3 hours)
  - "A Trauma-Informed Approach to Supporting Organizational Wellness" (1.5 hours) -- targeted to Administrators and School Leaders
  - "Caring for Yourself and Others: A Trauma-Informed Approach to Self-Care" (1.5 hours)
- 2. Mental health professionals available for consultation to administrators Primarily serve as thinking partners to help administrators know how to best plan for possible crisis situations and/or address current crisis situations.
- 3. Mental health assessments Can connect students/families with AR Connect (available to anyone ages 5 or older) to help connect them to long-term care mental health services. Designed to reduce barriers to mental health services.
- 4. Resource dissemination -Can provide fact sheets, brochures, etc. on how to talk to students/children about trauma-related events.

## **Professional Development for ADE Licensure**

Below are the training requirements for licensure renewal. There are some slight changes to the previous requirements.

- <u>Child Maltreatment Mandated Reporter:</u> In the 2021-2022 school year and every fourth year thereafter, all educators shall obtain two (2) hours of professional development in Child Maltreatment. The training can be done through Arkansas IDEAS.
- <u>Parent Involvement:</u> In the 2022-2023 school year and every fourth school year thereafter, each teacher and school administrator shall be required to have two (2) hours of professional development designed to enhance understanding of effective parent involvement strategies.
- <u>Teen Suicide Awareness and Prevention/Bullying:</u> In the 2023-2024 school year and every fourth school year thereafter, all educators shall obtain two (2) hours of professional development in teen suicide awareness and prevention.
- <u>Arkansas History:</u> In the 2024-2025 school year and every fourth school year thereafter, each teacher who provides instruction in Arkansas history shall obtain two (2) hours of professional development in Arkansas history.

The Right to Read Act (1063) states: "By the beginning of the 2021-2022 school year: A) All teachers employed in a teaching position that requires an elementary education (K-6) license or special education (K-12) license shall demonstrate proficiency in knowledge and practices of scientific reading instruction; and B) All other teachers shall demonstrate awareness in knowledge and practices of scientific reading instruction." Here is a link to options to meet this requirement. Act 489 extends the deadline for the training to the 2023-2024 school year.

#### **Arkansas Activities Association / AAA**

The AAA Governing Body Meeting was held on July 26, 2022. The focus of the meeting was to consider the following six proposals to amend the AAA Constitution and Bylaws which were voted on by the state membership.

Proposal No. 1 / NEW Competitive Equity Football	* Failed
To eliminate the competitive equity factor in all sports except for football. To allow schools to go back to	
traditional 8-team conferences and restore previous balance.	
Proposal No. 2 / Volleyball, Soccer, & Basketball Regular Season Game Limit	* Passed
To allow for flexibility in scheduling for teams from all classifications.	
Proposal No. 3 / Recruiting Rule	* Passed
To provide clarity concerning the recruiting rule.	
Proposal No. 4 / Penalties	* Passed
To provide clarity on the penalties associated with failing to comply with the rules and regulations of the	
Arkansas Activities Association.	
Proposal No. 5 / School Board Actions Recognized	* Passed
To maintain eligibility guidelines for magnet, specialty, and competitive entry schools that do not have	
specific attendance zones.	

To clarify eligibility rules associated with transfers.

### **ANSAA's Mission and Advocacy Work**

These efforts include working with the Arkansas Department of Education to provide professional development, national and state recognition and verification of our accredited schools, clarification of regulations and state laws pertaining to private schools, and inclusion in state programs such as non-traditional licensure. Additionally, ANSAA works with national organizations such as NFNSSAA and CAPE to provide schools with national networking acknowledgement. Throughout the 2020-2022 school years, a lot of effort was made to provide continuous information regarding legislation related to federal programs including ESSER, GEER, and EANS. These efforts require a financial commitment, which has been offset by pursuing ANSAA Corporate Sponsorships. ### **Federal Funds**

**ESSER I** (state level)- The DESE consulted with the ANSAA office about equitable services at the state level totaling \$261,082.21. Diagnostic assessment tools for grades 3-8 (ISIP Istation; NWEA Map Growth; Renaissance STAR) were utilized by many schools during the 2020-2021 and 2021-2022 school years, utilizing these funds. This has been extended to the 2022-2023 school year for previously participating schools.

**GEER I** (**state level**)- ANSAA was contacted by the Arkansas Department of Education Division of Elementary and Secondary Education regarding equitable services from state level GEER I (Governor's Emergency Education Relief Fund) from the original coronavirus relief package (CARES Act). The equitable portion totaling about \$184,000 has been distributed through grants to nonpublic schools in the state to reimburse for testing designed to identify learning loss. **EANS (CRSSA)** -\$22,872,412 has been allocated for the private schools in Arkansas. Fifty schools submitted an application for participation and were approved. About half of the funds have been spent.

**EANS II (ARP)** – Another \$22,872,412 was made available to eligible schools. Eligibility requirements included low poverty enrollment. Seven schools were approved.

Note that electronic filing is required for accredited schools.

### ANSAA Forms, Reports, & Fees - Due September 15

All forms and information related to the ANSAA Annual Report must be submitted, either electronically or by mail, according to the directives provided below, to the ANSAA office by the September 15, 2022. If the forms and/or payments are submitted after the September 15<sup>th</sup> deadline, include a late fee of \$100.

#### **ANSAA Policy Manual**

The ANSAA Policy Manual Edition 2022 will be used as a reference to identify all ANSAA Standards. Annual Report Forms (Elementary, Secondary, and Non-Accredited) are correlated to the 2022 Policy Manual Edition, which was e-mailed to all head administrators in August 2022.

\*The following schools must apply for ANSAA Renewal during the 2022-2023 school year (due the fourth year of the seven-year cycle): The Anthony School, Little Rock; Arkansas Christian Academy, Bryant; Christ Lutheran School, Little Rock; Harvest Time Academy, Fort Smith; Pulaski Academy, Little Rock; Shiloh Christian School, Springdale; Southwest Christian Academy, Little Rock; and St. John Catholic School, Russellville. Schools must include with the renewal form a \$100 filing fee and a copy of the school's current Strategic Plan.
